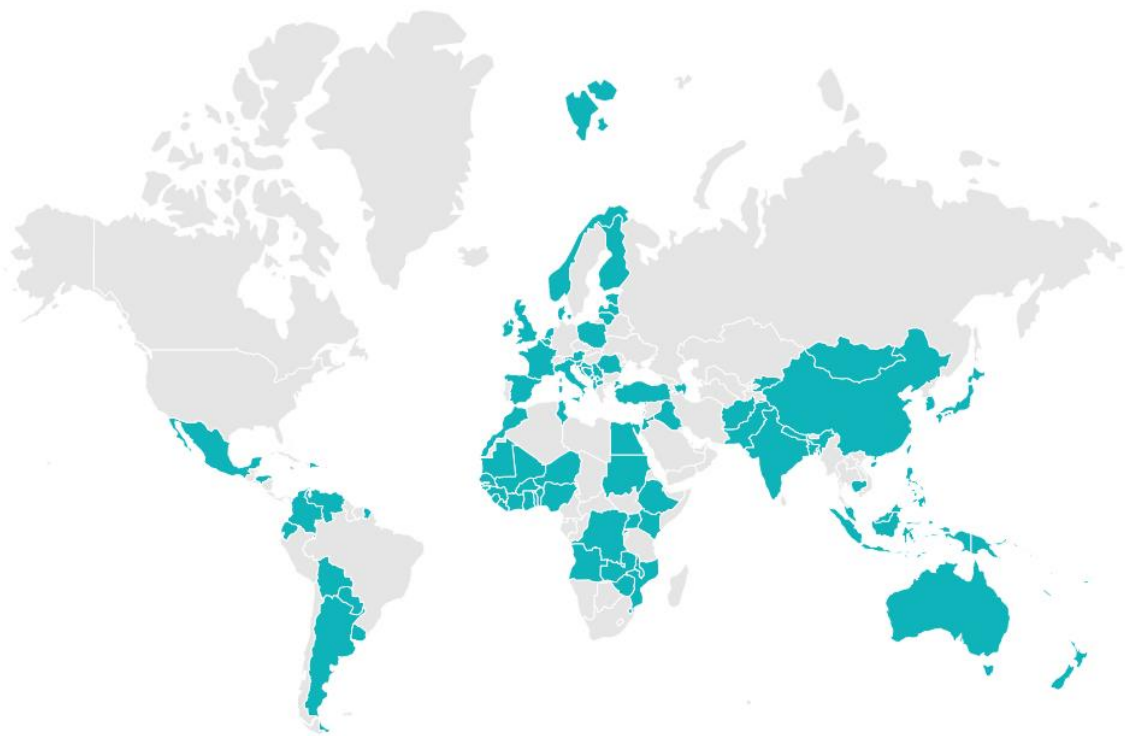

CIVIL SOCIETY ORGANIZATION NETWORK FOR DEVELOPMENT (RESOCIDE)

BURKINA FASO

RESOCIDE is a network formed by 14 organizations focusing on the contribution to fair global governance, conducting research on the different aspects of civil society and promoting human rights at national level. To achieve its different goals, RESOCIDE has developed links with some regional and global civil society umbrellas like the West African Civil Society Forum (WACSOF), the West African Human Rights Defenders Network (ROADDH), and CIVICUS. At national level, RESOCIDE initiated a coalition of CSOs to monitor public policies, particularly in the field of poverty reduction and decentralization called CDC/CSLP which it chairs.

RWANDA

Founded in 1987, CCOAIB (Conseil de Concertation des Organisations d'Appui aux Initiatives de Base) is an umbrella organisation of 36 local NGOs across Rwanda. CCOAIB was created in Rwanda in 1987 in order to have a framework for exchange, dialogue and negotiation for NGOs. 40 members are now represented in this Council and they work in various fields: agriculture and animal husbandry, beekeeping, food processing, housing, crafts, women's entrepreneurship, hydraulic rural, mentoring youth and orphans, the supervision of cooperatives, microfinance, etc.

COORDINATING ASSEMBLY OF NGOS (CANGO)
